

NOTICE OF CITY OF PASADENA RUNOFF ELECTION

TO THE QUALIFIED VOTERS OF PASADENA, HARRIS COUNTY, TEXAS:

NOTICE IS HEREBY GIVEN that the City of Pasadena, Texas will conduct a Runoff Election which will be jointly held with Harris County on **June 7, 2025 between the hours of 7:00 a.m. and 7:00 p.m.** for the purpose of electing a mayor and councilmembers for Districts A, B, and G.

Persons Entitled to Vote: Only voters of the City of Pasadena, Texas who are qualified under state and federal law shall be allowed to vote in this Election.

Early Voting and Election Day Voting by Personal Appearance: The Main Early Voting Location for Early Voting by personal appearance is located at the Harris County Attorney Conference Center, 1019 Congress Avenue, Houston, TX, 77002. In this election, Early Voting and Election Day Voting locations shall be conducted at the locations established by the Commissioner's Court of Harris County in accordance with the provisions of the Election Code. Voters may vote at any of those locations during Early Voting and Election Day. Lists of Early Voting and Election Day locations are attached hereto as Exhibits "A" and "B" and may be modified to include additional or different voting locations up until Election Day. Voting locations for this election will be posted on the County's website at <https://www.harrisvotes.com>, on the City's website at <https://www.pasadenatx.gov> and at Pasadena City Hall, 1149 Ellsworth Drive, Pasadena, Texas, 77506.


Hours for Early and Election Day Voting by Personal Appearance:

Early Voting	May 27, 2025 through May 31, 2025	7:00 a.m. to 7:00 p.m.
Early Voting	June 1, 2025	12:00 p.m. to 7:00 p.m.
Early Voting	June 2, 2025 through June 3, 2025	7:00 a.m. to 7:00 p.m.
Election Day	June 7, 2025	7:00 a.m. to 7:00 p.m.

Ballot by Mail: All Applications for Ballots by Mail and Federal Post Card Applications received during the period allowed by the Texas Election Code shall be sent by regular mail to: Office of Teneshia Hudspeth, Harris County Clerk's Office Elections Department, P.O. Box 1148, Houston, TX 77251-1148. They may also be sent by common or contract carrier to: Office of Teneshia Hudspeth, Harris County Clerk's Office Elections Department at following locations: 1001 Preston, 4th Floor, Houston, TX 77002 or 15600 Morales Road, Houston, TX 77032. An application may also be submitted by fax to 713-755-4983 or 713-755-2617, or by email at vbm@HarrisVotes.com, vbm@vote.hctx.net or ada@vote.hctx.net. If an application is faxed or emailed it must also be submitted by mail to the joint early voting clerk no later than the fourth business day after the transmission by fax or email is received. Applications for Ballots by Mail and Federal Post Card Applications must be received by May 27, 2025. Mail Ballots must be received and postmarked no later than 7:00 p.m. on June 7, 2025, unless overseas deadline applies. Late domestic ballots must be received no later than 5:00 p.m. on June 9, 2025, however, these ballots must be postmarked no later than 7:00 p.m. on June 7, 2025.
