I hereby plead no contest to the charge of _____, waive trial by jury, and to discovery, and request that the court grant deferred disposition. I understand that to qualify I must have a Texas driver's license and evidence of financial responsibility (insurance). In addition, I understand that I must pay a fine in the amount of the "window fine" found below plus twenty (\$20.00) dollars. For seatbelt violations 15 years and over send \$180.00. I understand also that I cannot already be on deferred disposition in the Pasadena Municipal Court for another violation. I understand that I am not eligible if I am now or was at the time of the citation the holder of a commercial driver's license or if I have been cited for a violation occurring in a construction zone when workers were present. I understand that if I am under the age of 25, I must complete a driving safety course as a condition of deferred disposition and if I have a provisional driver's license, I will also be required to retake my driving test and pay the cost thereof.

DEFERRED DISPOSITION APPLICATION CHECKLIST:

- Enclosed is a copy of my Texas driver's license and proof of financial responsibility (insurance)
Enclosed is a check or money order for the amount of the fine plus twenty (\$20.00) dollars except for seatbelt violations 15 years and over send only the amount of the window fine (\$180.00). DO NOT SEND CASH BY MAIL OR PUT CASH IN THE NIGHT DROP BOX
I am not presently on deferred disposition in this court
I do not have a CDL, nor did I have a CDL when I was cited
I was not cited for a violation that occurred in a construction zone when workers were present
If I am under 25 years of age, I understand that I'll be required to complete a driving safety course as an additional condition of deferred disposition
If I have a provisional driver's license, I understand that I'll not only have to complete a driving safety course but retake my driving test as well

All other cases (including equipment violations) may be dismissed only with the State's recommendation.

INFORMATION ABOUT AND APPLICATION FOR DRIVING SAFETY COURSE

The law requires the court to advise persons charged with certain misdemeanors under Subtitle C, Title 7, Transportation Code and committed while operating a motor vehicle of their right to successfully complete a driving safety course or motorcycle operator training course. To be eligible to apply for the course, you must not have completed an approved driving safety course or motorcycle operator training course within the 12 months preceding the date of the offense and must fully comply with the terms of the **application below**. **The course is not available for dismissal of violations of law relating to insurance, driver's license, license plates, speeding 25 m.p.h. or more over the posted limit, speeding 95 m.p.h. or more, passing a school bus, reckless driving, fleeing a peace officer, failure to stop and give information, failure to stop and render aid, violations occurring in a construction zone when workers were present or other serious traffic violations. You are also not eligible if you are now or were at the time you were cited the holder of a commercial driver's license.**

You may qualify for a driving course by mailing the application and unsworn declaration found below fully completed by certified mail, return receipt requested to Pasadena Municipal court, P.O. Box 1575, Pasadena, Texas 77501-1575 postmarked on or before the court date on your ticket **OR** by applying in person at the Court's transaction windows. Your application and affidavit must be accompanied by a check or money order in the amount stated in the application. Cash payment can be accepted only when an application is made in person. Upon receipt of a completed application, verification of license and insurance information and payment the appropriate fee and costs, you will be sent further instructions by the Court. **DO NOT TAKE THE COURSE UNTIL YOU ARE AUTHORIZED TO DO SO BY THE COURT.** The court costs and fee are not refundable. In addition to the court costs that are due with this application, you will also be responsible to pay the fees charged by the driving school and pay for the cost of your driving record as well. Information regarding how to obtain a driving record will be returned to you by the court. Only driving safety programs approved by the Texas Department of licensing and Regulation will be accepted by the court. If you complete the driving safety course within the time required and return the certificate together with a copy of your driving record to the court, the charge against you will be dismissed and the court will report to the Department of Public Safety the completion date of the driving safety course for inclusion in your driving record. If you should fail to present proof of completion of the driving safety course together with a copy of your driving record within the time prescribed, the court will summon you to appear and show cause why a final judgment should not be entered and a conviction reported to the Department of Public Safety. **To request a driving safety course, please complete the application and unsworn declaration found below.**

I hereby waive my right to a jury trial, and to discovery, and plead no contest to the charge of _____ and elect to take a driving safety course. I understand that I must:

1. Present to the court a valid **Texas** driver's license or permit unless I am active duty military or a military dependant. **A copy of my driver's license is enclosed;**
2. Present to the court proof of current financial responsibility (automobile liability insurance). I understand that **my name** must appear on the policy or identification card. **A copy of my proof is enclosed;**
3. Pay court cost and reimbursement fee of \$144.00 for cases **not in** school zones. Pay \$169.00 for cases **in** school zones. **Payment is enclosed.**

AFTER MY APPLICATION IS APPROVED, I MUST:

4. Return to the court a certified copy of my driving record from the Department of Public Safety showing that I have not completed an approved program within the 12 months preceding the date of the offense. This must be done **within 90 days from the date that the court approves this application; and,**
5. Return to the court a certificate of driving safety course completion from a Texas Department of Licensing and Regulation approved course. This must be done **within 90 days from the date that the court approves this application.**
