BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PASADENA, TEXAS:

EL CONSEJO MUNICIPAL DE LA CIUDAD DE PASADENA, TEXAS, RESUELVE:

Section 1. In compliance with Article IV of the Home Rule Charter of the City of Pasadena and Vernon's Texas Civil Statutes, Texas Election Code and Texas Constitution, a General Election is ORDERED and shall be held in and throughout the City of Pasadena, Harris County, Texas, on Saturday, May 3, 2025 between the hours of 7:00 o'clock a.m. and 7:00 o'clock p.m. and at said election the qualified voters of the City of Pasadena shall elect a Mayor to serve for a period of four (4) years and eight (8) single-member Councilmembers to serve for a period of two (2) years, respectively.

Sección 1. *En cumplimiento con el Artículo IV de la Carta Orgánica de Gobierno Autónomo de la Ciudad de Pasadena y los Estatutos Civiles de Texas de Vernon, el Código Electoral de Texas y la Constitución de Texas, se ORDENA una*

Elección General y se celebrará en la Ciudad de Pasadena, Condado de Harris, Texas, y por toda la misma, el sábado 6 de mayo de 2025 en el horario de 7:00 a.m. a 7.00 p.m. y en la cual los votantes habilitados de la Ciudad de Pasadena elegirán un alcalde para fungir por un periodo de cuatro (4) años y ocho (8) concejales para distritos con miembro único para fungir por un periodo de dos (2) años, respectivamente.

Section 2. The Election shall be conducted as a joint election under Chapter 271 of the Texas Election Code and be conducted by the Harris County Clerk's Office Elections Department, on behalf of the City under a contract for election services approved by City Council. The Harris County Clerk, Teneshia Hudspeth, will serve as the Joint Early Voting Clerk in this election.

Section 3. On Election Day, the polls shall be open from 7:00 a.m. to 7:00 p.m. Early Voting begins on April 22, 2025 and ends on April 29, 2025. Early Voting dates and hours are set forth in Exhibit "A" attached hereto and incorporated herein for all purposes. The Main Early Voting Location for Early Voting by personal appearance is located at the Harris County Attorney Conference Center, County Conference Center III/Meeting Room 109, 1019 Congress Avenue, Houston, TX, 77002 (Subject to change up until Election Day). Election Day Voting and Early Voting shall be conducted at the locations established by the Commissioner's Court of Harris County in accordance with the provisions of the Election Code. When these locations become available, they will be posted on the County's website at <https://harrisvotes.com>, on the City's website at <https://www.pasadenatx.gov> and at Pasadena City Hall, 1149 Ellsworth Drive, Pasadena, Texas, 77506.

Sección 3. *El Día de Elección las casillas abrirán de 7:00 a. m. a 7:00 p. m. La Votación Anticipada comienza el 22 de abril de 2025 y finaliza el 29 de abril de 2025. Las fechas y los horarios de votación anticipada son los que se indican en el Anexo "A" adjunto e incorporado a la presente para todo fin. El principal lugar de votación anticipada en persona se ubica en el Harris County Attorney Conference Center, Centro de conferencias III del Condado/Sala de reuniones 109 sito en 1019 Congress Avenue, Houston, TX, 77002 (Sujeto a cambios hasta el Día de Elección). La votación el Día de Elección y la votación anticipada se llevarán a cabo en lugares establecidos por el Tribunal de Comisionados del Condado de Harris en conformidad con las disposiciones*

del Código Electoral. Cuando estén disponibles estos lugares, se anunciarán en el sitio web del Condado en <https://harrisvotes.com>, en el sitio web de la Ciudad en <https://www.pasadenatx.gov> y en la Alcaldía de Pasadena ubicada en 1149 Ellsworth Drive, Pasadena, Texas, 77506.

Section 4. All Applications for Ballots by Mail and Federal Post Card Applications received during the period allowed by the Texas Election Code shall be sent by regular mail to: Office of Teneshia Hudspeth, Harris County Clerk's Office Elections Department, P.O. Box 1148, Houston, TX 77251-1148. They may also be sent by common or contract carrier to: Office of Teneshia Hudspeth, Harris County Clerk's Office Elections Department at following locations: 1001 Preston, 4th Floor, Houston, TX 77002 or 15600 Morales Road, Houston, TX 77032. An application may also be submitted by fax to 713-755-4983 or 713-755-2617, or by email at vbm@HarrisVotes.com, vbm@vote.hctx.net or ada@vote.hctx.net. If an application is faxed or emailed it must also be submitted by mail to the joint early voting clerk no later than the fourth business day after the transmission by fax or email is received. Applications for Ballots by Mail and Federal Post Card Applications must be received by April 22, 2025.

Sección 4. *Todas las solicitudes de boletas de voto postal y las solicitudes de postal federal recibidas durante el periodo permitido por el Código Electoral de Texas serán enviadas por correo postal regular a: Office of Teneshia Hudspeth, Harris County Clerk's Office Elections Department, P.O. Si se envía una solicitud por fax o correo electrónico, también debe enviarse por correo al oficial de votación anticipada conjunto a más tardar el cuarto día laborable posterior a que se reciba la transmisión por fax o correo electrónico. Las solicitudes de boletas de voto postal y solicitudes de postales federales deben ser recibidas para el 22 de abril de 2025.*


Section 5. Said election shall be held and conducted in accordance with the provisions of the Texas Election Code and City of Pasadena's Home Rule Charter.

Section 6. Notice of the Election, stating in substance the contents of this order, shall be published in the English and Spanish languages in a newspaper published within the City's territory at least ten (10) days and no more than thirty (30) days before the Election.

Section 7. There are sufficient funds in Election Fund Account 11000 to provide for expenses incurred in such election.

Section 8. The City Council officially determines that a sufficient written notice of the date, hour, place and subject of this meeting at which this Election Order is adopted was posted at a place convenient to the public at the City Hall of the City for at least seventy-two (72) hours preceding the scheduled time of the meeting, as required by the Open Meetings Law, Chapter 551, Texas Government Code; and that this meeting has been open to the public as required by law at all times during which this resolution and the subject matter thereof has been discussed, considered and formally acted upon. The City Council further confirms such written notice and the contents and posting thereof.
